

Joining our South Square and Mourant speakers is a line-up of highly regarded guest panellists from London, Hong Kong and the Cayman Islands.

This year's keynote address will be delivered by former senior parliamentarian Luciana Berger. Elected as an MP in 2010, Luciana served as Shadow Minister for Energy and Climate Change, then as Shadow Minister for Public Health, before being appointed as the first ever Shadow Minister for Mental Health. Today, Luciana's political, charity, and advisory work in health, sustainability, energy, and climate change continues to shape public policy and influence discourse throughout the UK.

In her keynote speech, Luciana will draw from her extensive experience of parliament and public policy to explore what we can expect from the new government in navigating complex challenges such as climate change and mental health. She will also discuss the critical role of the rule of law in safeguarding civil rights and combating discrimination, touching on her personal experiences with antisemitism and relating these to the current polarised political climate.

The Forum will begin with two sessions drawing upon the litigation expertise of Mourant, South Square and our guest speakers. The areas for discussion are:

• Injunctions in fraud litigation

Chloe Edworthy, Jonathan Moffat, Stephen Robins, and Tal Goldsmith will address recent developments relating to injunctions including the legal expenses exception and the cross – undertaking in damages.

• In conversation with Mr Justice Segal

Georgina Peters and Michael Popkin will lead a fireside chat with Mr Justice Segal on a range of topical issues.


